- The US dollar level and net worth rises above the \$US¼ billion mark
- 2004 joins the ranks of Fortune 500 with \$US3.6 billion in revenue and \$US1 .7 billion in stockholders' equity at year end 2003
- In 2006 named *Best Managed Insurance Company* by Forbes Magazine
- In 2017 W. R. Berkley Corporation celebrated the 50th anniversary of its founding.
